

CENTEREACH HIGH SCHOOL PARKING REGULATIONS

Students with a class "D" license may apply for school parking permits. Parking privilege is subject to strict administrative control. To qualify for this privilege, the following conditions are to be observed.

1. Register all cars in the East Suite. Decals will be issued and must be attached to the front windshield, behind the rearview mirror.
2. Students must park in the designated area for student parking.
3. No student will loiter around the parking field, and all students will leave their cars immediately upon arrival and enter the building.
4. Students cannot re-enter cars until the close of school without administrator permission.
5. Students are not permitted to drive off the school grounds during the school day unless they have an authorized dismissal.
6. Students must observe the 10 MPH speed limit on school grounds.
7. No vehicles should produce undue noise as a result of improperly functioning mufflers, spinning of wheels, or loud radios.
8. IN THE EVENT OF AN ACCIDENT occurring while driving to and from school, it is the driver's (STUDENT) responsibility to file a report with the school nurse. Incidents in the parking lot are to be reported to security.
9. Failure to register an automobile will result in loss of the student's parking privileges.
10. Students are not permitted to drive to classes at Newfield High School unless they have a class "D" license and a Centereach High School Parking Permit. **Students are not permitted to drive to any BOCES program as per board policy.**
11. Suffolk County police will issue traffic tickets or summonses to automobiles illegally parked or operated on school property.
12. Class cutting and/or truancy may result in loss of parking privilege.
13. Students who violate any of the above regulations or who drive recklessly on school property will lose their privilege.
14. Automobiles parked on school property are subject to search.

The Middle Country Central School District is not responsible for property lost or damaged. Please complete the attached form and return to the East Suite. As indicated, a parking sticker must first be obtained in order to park on school grounds.
