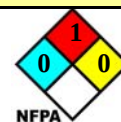

Rinse mouth with cold water. Give victim 1-2 cups of water or milk to drink. Induce vomiting immediately.**Inhalation:** Remove to fresh air. If not breathing, give artificial respiration.

Section 5: Fire Fighting Measures

Combustible solid. When heated to decomposition, emits acrid fumes.

Protective equipment and precautions for firefighters: Use foam or dry chemical to extinguish fire.
